## Posted Notice of Public Hearing for City of Pearland's Community Development Block Grant Program Action Plan Amendments and Additional Funding

The City of Pearland is preparing its FY 22 Annual Action Plan for the Community Development Block Grant program (CDBG). The City will conduct a public hearing at 6:30pm at the following location:

The hearing will be used to provide information about the spending activities involving the allocation of funds in support of eligible expenditures. This Public Hearing will initiate a 30-day comment period from June 15, 2021 – July 16, 2021, for citizens and public officials to provide input, discussion and make recommendations on the City's Plan.

## **About the Funding**

The U.S. Department of Housing & Urban Development (HUD) provides an annual formula allocation of funding to the City, via the CDBG program. CDBG funding is available to serve low-moderate income individuals, households and areas of the Entitlement Jurisdiction, which in the case of Pearland began in 2006 when its population exceeded 50,000. A total of \$455,947 has been made available by HUD to the City of Pearland for FY 2022. This public hearing will also be used to inform the public about the availability of those funds and what they may and may not be used for.
